- I. Minutes from February 6, 2006 were accepted.
- II. **Guest Speaker**: Dane Netherton, Office of Public Affairs, spoke about the Faculty Survey that is being developed. Purpose: to obtain data and access awareness of transformation teams, market research, census. The sample will include 150 Faculty members and will be an anonymous phone survey. Discussion around how the 150 are selected, possibility of emailing survey first, follow up by phone. \*\*Call for vote that all faculty be polled, rather than just 150 members\*\*

- III. **Faculty Representative to Board of Trustees**: Michael Carter Tuition fee increases have passed, 3.4% across all campuses. Dorm fees increase 3.3% (over 7% at Amherst & Dartmouth); Affirmative Action commitment; Education Funding Bill: in Senate now, thinking that once version comes out of House, won't be as positive; solar power research venture capital; speculation that tenure decisions might be looked at more closely.
